2. Details of Progress

A. Analysis and Strategy for Sustainable Palm Oil

1. High-level strategic view of the organisation's relation to sustainable palm oil and related longer term objective.

Boustead Plantations Berhad is committed towards sustainability and producing sustainable Palm and Palm Oils to our client's world wide. Sustainable agriculture is not only about protecting the environment but in essence it is embed in these 3 tenets of sustainability 1) People 2) Planet 3) Profit, where human resource share equal importance with profitability, have become the cornerstone of modern agricultural today. Therefore, we are pleased to note that essence of sustainable agriculture has been ingrained in our operations, management and administration of Boustead Group's plantation division, which has its roots that span well over fifty years. Since the very beginning of our operations, Boustead Plantations has been committed to develop and cement the best practices that lead to sustainability of our business. We have over the years stayed firm to our Good Agricultural Practice (GAP) and Good Milling Practice (GMP) which provide us set of guidelines and a foundation towards achieving the goals of sustainable agriculture as outlined in our 'Towards Sustainable Agriculture' handbook. Boustead Plantations is a keen advocate on the use of technology to improve our processes and operations in all aspect related to sustainable agriculture. Hence, we are committed to get all of our Operating units RSPO certified by 2015.

3. Targets for the next reporting period.

In the next report, we will be reporting on Sungai Jernih business unit as it will be certified by the first quarter of 2011. We will also report on the progress of the other business units that will be certified as per our time bound plan stipulated below.

Boustead Biotherm Palmass PlantTM is now fully operational. The plant capacity and efficiency have improved significantly since it was commissioned in April 2009, particularly in reducing the CH_4 emission via utilization of mill effluent, reducing the N₂O emission by substituting the inorganic nitrogenous fertilizers with organic fertilizer, increasing the carbon sequestration through mulching and indirect reduction of CO_2 emission from fertilizer transportation.

4. Statement from the organisation's senior representative.

Boustead Plantations adopted a strategy to steer the Group not only towards optimising efficiency, productivity and profitability but also commitment towards environmental protection and conservation of biodiversity.

B. Progress made in producing, procuring/utilizing and supporting sustainable palm oil

 The Company had engaged SGS to conduct a Pre-Assessment on Sungai Jernih Business Unit on April 2010. The purpose of the evaluation was to evaluate the operations of the aforesaid business unit against RSPO P & C MYNI requirements in preparation for the actual certification audit in the first quarter of 2011. We are now in the process of rectifying all the non compliance as highlighted by SGS during the pre-assessment and improving all the documentation.

Boustead Time Line on RSPO Certification

- Boustead is fully committed to its time-bound plan for certifying all its business units by 2015 and will submit to the Certification Body (CB) during the first certification audit. All of our Business Units understood the time bound plan and are in the process of complying with the requirements for RSPO partial certification for non-certified units.
- Boustead also had engaged Wild Asia to conduct SIA and HCV. From the report we have learned :
 - a) The social context within and surrounding its properties ie Sungai Jernih Estate, Bebar Estate and Tabung Tentera Trengganu Estate internal and external setting. Hence, Sungai Jernih Business unit had initiate consultation/meeting with stake holders, local and estate community, local authority such as Police, Rela and local NGO on the current perception of the company operations and benefits. From the aforesaid meetings it provided the company a rapid assessment of perceived positive and negative impacts of the operation. It also provides guidance to the management on areas of improvements.
 - b) The HCV Assessment had identify areas of High Conservation Value (HCV) through a swift survey of biodiversity and values to local communities of areas visited. Conservation values areas which did not qualify for HCV status were also identified. All Recommendations forwarded will be studied and evaluated. Boustead is committed at reducing negative impacts and enhancing positive ones are made for both HCV and non-HCV areas.

C. Challenges

1. Significant economic, social or environmental obstacles encountered in production, procurement, use of sustainable palm oil or in promotion of RSPO and RSPO oil and efforts made to mitigate or resolve them.

The challenge that most plantation companies are facing now is sustaining a stable and skilled workforce on the ground. The company has implemented division of labour system and semimechanisation such as the use of mechanise harvesting knife is also being explored to overcome acute labour shortage. We also looked on various options like; allowances, improvements in living conditions, improve working conditions and other social activities.

Fluctuation and increase in the prices of inputs such as fertilizer and fuel is putting a stress on the production cost which is being lessened by adopting good agricultural practices and focusing on site-specific agronomic practices, efficient utilisation of inorganic fertilisers, efficient management of resources for high yields and sustainable development for our estates.

Engagement with stake holders is not a problem as we are open and transparent. However, to get all the stake holders to attend the stake holders meeting, to mitigate and resolve issues at hand are quite challenging.
