




Figure 2: Raja Hitam Estate






Figure 3: Lekir Estate






Figure 4: Kampar Estate






Figure 5: Changkat Chermin Estate






Figure 6: Bukit Katho Estate






Figure 7: Allagar Estate






Figure 8: Kuala Kangsar Estate (Gapis Division)







Figure 9: Kuala Kangsar Estate (Selinsing Division)

Figure 10: Glenealy Estate - (Home Division)






Figure 11: Glenealy Estate - (Parit Division)






Figure 12: Glenealy Estate – (Reyland Division)






Figure 13: Glenealy Estate - (Senggang Division)






Figure 14: Pinji Estate – (Hillrise Division)






Figure 15: Pinji Estate – (Meranti Lapan Division) & Batu Dua Estate






Figure 16: Menglembu Estate
