Activities undertaken to promote sustainable palm oil to date	In 2010-2011 Oxfam contributed to the financing of the RSPO through facilitating the search for funds of external donors. Oxfam has developed programme to secure resources for upscaling sustainable palm oil to protect and benefit communities, smallholders and labour. This has resulted in time bound plans for the functioning and the contracting, together with the RSPO secretariat of a manager for the the Smallholder Task Force and the Dispute Settlement Facility. Part of the planned programme for the future is to also go beyond RSPO (the role of governments, emerging markets, other vegetable oil markets). Currently Oxfam Novib is exploring with the Dutch Sustainable Trade Initiative (IDH) possibilities of				
	collaboration and support to Oxfam and the RSPO. In 2010-2011 Oxfam contributed to the work of the RSPO and its structure in several ways: * Active board membership; * Membership of Standards and Certification (S&C working group), Greenhouse Gas working group; * Active membership of the Trade and Traceability (T&T working group); * Active membership of the Communication and Claims (C&C working group, interaction with brands and retailers in Unilever coalition); * Since April 2011 Oxfam provides one of the co leads for the Task Force on Smallholders; * Oxfam is chairing the Grievances Panel of the RSPO; * Continuous dialogue with companies for increased market uptake of Sustainable Palm Oil, including monitoring of timebound plans in the annual progress reports by members; * Publication of analysis of Colombia National Interpretation process: Responsibility and sustainability of the palm oil industry, are the principles and criteria of the RSPO feasible in Colombia?; * Faciliation role during Roundtable conference RT8 pre-meetings and plenary presentation about a supply-demand forecast scenario; * Support to Sawit Watch, other civil society partners and RSPO allies; In 2010-2011 Oxfam also carried out palm oil relatied activities that are not necesarily RSPO activities, but do contribute to sustainable palm oil. Examples of these activities are: * The publication of a joint Oxfam- Prince Rainforest Project report: Analysis of the Agronomic and Institutional Constraints to Smallholder Yield Improvement in Indonesia; * Active contribution to the consultation process on the development of the World Bank Group Frame Work and IFC strategy to guide future investment in palm oil; * Oxfam has started a campaign - GROW - on addressing the failing food system, advocating for favouring smallholder agriculture and for private sector actors to take their responsibility in sustainable production and against land grabbing.
