As an introduction, Asia Pacific Exchange (APEX) is the 3rd Derivatives Exchange regulated by the Monetary Authority of Singapore. We have two futures contracts on Palm Oil: RBD Palm Olein ("PF") and Crude Palm Oil ("CPF"), both of which are physically deliverable on FOB terms. On a monthly basis, we do have an average 10,000-20,000mt delivery taking place from both Indonesia and Malaysia and is gradually attracting more traders internationally.

In this regards, we would like to designate all RSPO certified producers as Asia Pacific Exchange's ("APEX") approved suppliers for the CPF and PF contracts without having these organizations to make applications as compared to Non-RSPO producers that will be required to go through an evaluation and approval process with APEX.
