Brief description	Agropalma started its palm oil activities in 1982 in Brazil, leading nowadays the palm oil production in Latin America, plus controlling the entire production chain, from seedling to RBD conventional and organic palm and palm kernel oils, vegetable fats and margarines, and more recently, bio-diesel production. The Agropalma complex today reaches 35,000 ha of planted area, four mills with an extraction capacity of 128 tons of FFB/hour, one refinery and fractionation plant plus a shortening and margarine production unit. Surrounding the plantations, the company has over 55,000 hectares of natural forests reserves, protecting all wildlife, including more than 300 different species of birds. The entire Group is certified with the ISO 9001:2000, ISO 14001:1996 and the OHSAS 18001.
