# 5.1 Outline actions that you will take in the coming year to promote the use of RSPO-certified sustainable palm oil and oil palm products along the supply chain.

Remia will continue to promote certified sustainable palm oil or palm products among customers. Sustainability issues are not only discussed internally but also with all vegetable oil suppliers and consumers of products that contain vegetable oils. Customers are offered the option to buy Remia,Äôs end products as RSPO certified products. As Remia has been certified for the supply chain models SG and MB, these are the two options that can be chosen out of the product range that is offered. Although it is very important to keep our direct customers well informed about the progress that has been made on sustainability targets, it might be even more important that end consumers are aware that their buying behaviour can make a difference. Their knowledge about the adverse consequences of large scale palmoil productions should be improved. Once the end consumer is aware of these problems and prepared to pay extra for products that contain sustainable palm oil, the sustainability transformation will accelerate. The role of the Government seems to be crucial in this respect.
