Notification of RSPO Initial Assessment of Extractora Sicarare SAS, COLOMBIA RSPO Membership: 2-0637-16-000-00

To Whom It May Concern:

Extractora Sicarare SAS of Colombia has commissioned SCS Global Services to conduct an RSPO Initial Assessment of its palm oil mill and supply basin located near KM 11 Al Sur De Codazzi, Departamento Del Cesar. The assessment will be conducted of 1 Palm Oil Mill and 02 Oil Palm Plantations.

SCS Global Services plans to conduct the Initial assessment of the Extractora Sicarare SAS mill from **22-24 of October 2019.** The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2013), using as reference the National Interpretation of the P&Cs for the **COLOMBIA** and the RSPO Supply Chain Certification Standard – CPO Mills (June 2017).

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
