Dear Stakeholders.

This is to inform that the above Management Unit under the Parent Company FGV Holdings Berhad with RSPO membership number 1-0225-16-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit (RA-01)/Surveillance Audit at Bukit Kepayang POM and its supply base, located at Pahang, Malaysia. The audit will be conducted from 14 - 17 November 2023 against the requirements of:


