Dear Stakeholders.

This is to inform that the above Management Unit under the Parent Company Keck Seng (Malaysia) Berhad with RSPO membership number 2-0094-08-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit (RA-01)/Surveillance Audit at Masai POM and its supply base, located at Masai, Johor. The audit will be conducted from 17 - 21 October 2022 against the requirements of:

In brief, Keck Seng (Malaysia) Berhad is a public listed company on the Main Board of Bursa Malaysia and one of its activities is an integrated palm oil producer.
