Green's Foods Holdings will continue to urge all manufacturers and distributors who supply the company with PO products to become RSPO members and gain RSPO SCCS certification or distributor licences in order to maintain the auditable supply chain. 2. 99.3% of all palm oil / palm oil derivatives used by the company are from CSPO. We will endeavour to get the remaining amount of palm oil / palm derivatives supplied as CSPO to achieve 100%. Where this is not possible we will endeavour to find non palm alternatives where these are available and perform as viable alternatives.

3. Progress has been made in 2018 with more raw materials being purchased to the segregated certification level. Our objective is to continue to move to higher level certified palm oil and palm oil derivatives where these are commercially available.
