The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement 1 (one) mill and 3 (three) estates on **28 November to 02 December 2022**.

PT Pinang Witmas Sejati is part of the Kuala Lumpur Kepong Group and is divided into 3 estates and 1 mill:

PT Pinang Witmas Sejati did not undergo the NPP process because the land was already open before 2009.

There is a remediation area in PWS Estate with a total area of 464.4 ha and the remediation program has been approved by the RSPO on 09 September 2022.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has
