### Notification on RSPO Initial Assessment of PT Austindo Nusantara Jaya Agri Siais (ANJA Siais POM)

Dear Stakeholders,

PT Austindo Nusantara Jaya Agri has applied to Mutuagung Lestari for Initial Assessment at PT Austindo Nusantara Jaya Agri – ANJA Siais Palm Oil Mill and its supply based as one of subsidiary, located on Pardomuan Village, Angkola Selatan Sub-district, Tapanuli Selatan District, North Sumatera Province against the requirement of the RSPO Standard i.e. National Interpretation of Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO INA – NIWG, May 2008) Republic of Indonesia and Supply Chain Requirement for CPO Mill.

PT Austindo Nusantara Jaya Agri operated 3 (three) palm oil mills and 7 (seven) estates throughout Indonesia. The company is implementing programme to achieve RSPO Certified Sustainable Palm Oil for all of its production. PT Mutuagung Lestari has arranged to conduct the certification assessment of 1 (one) mill and 1 (one) plantation consisting of 3 (three) estates on **28 April – 3 May 2014.**
