PT Mutuagung Lestari will conduct Initial Certification Assessment at PT Agro Bukit (RSPO membership number 1-0175-14-000-00) – PT Agro Bukit and its supply base, located in Sawahan village, Mentaya Hilir Utara Sub District, Kotawaringin Timur District, Kalimantan Tengah Province, Indonesia against the requirement of the RSPO Standard i.e. National Interpretation of Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO INA – NIWG, May 2008) Republic of Indonesia and Supply Chain Requirment for CPO Mill.

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes. Goodhope Asia Holdings Ltd. implementing program to achieve RSPO Sustainable Palm Oil requirement for all of its production.
