PT Ladangrumpun Suburabadi has applied to Mutuagung Lestari and will conduct Re-Certification-2 at Angsana POM and its supply based, located at Sebamban Baru Village, Sei Loban Sub-District, Tanah Bumbu District, Kalimantan Selatan Province, Indonesia, against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Angsana POM has successfully been registered in the PalmTrace IT platform with member RSPO\_PO1000000325. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill, 2 (two) estates and 2 (two) smallholders full managed (KKPA) on 18 to 22 April 2022.

Apart from the estates and mills operation, Sime Darby Plantation Berhad is also involved in the downstream activities including oil refining, production of oil and fat products, oleo-chemical and biodiesel in fourteen countries.

PT Ladangrumpun Suburabadi is a company that is part of the Minamas Plantation group which is part of the Sime Darby Plantation Group. PT Ladangrumpun Suburabadi is headquartered at The Plaza Office Tower Lt. 36 Jl. Thamrin Kav. 28-30 Central Jakarta 10350. With the status of domestic investment capital and is engaged in plantations and palm oil processing

The total plantation concession area of PT Ladangrumpun Suburabadi is 15,151.19 ha. PT Ladangrumpun Suburabadi does not have a new planting program so it does not undergo the NPP (New Planting Procedure) process. The age of the oldest plant at PT Ladangrumpun Suburabadi has now reached 26 years (1995 year of planting) and has been replanted in stages. PT Ladangrumpun Suburabadi has started a replanting program since 2016.

LUCA for PT Ladangrumpun Suburabadi is completed and approved by RSPO on 04 May 2021.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China.
