Notification of RSPO Re-Certification KKP POM PT Karunia Kencana Permaisejati subsidiary of Wilmar International Ltd (RSPO Membership 2-0017-05-000-00, 16 August 2005)

Dear Stakeholders,

Wilmar International Ltd has applied to Mutuagung Lestari and will conduct Re-Certification at KKP POM and its supply based, located at Kenyala Village, Telawang Sub District, Kotawaringin Timur District, Kalimantan Tengah Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

KKP POM has successfully been registered in the PalmTrace IT platform with member RSPO_1000004150. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 3 (three) estates on **26 to 30 September 2022**.

PT Karunia Kencana Permaisejati (PT KKP) is a company with PMA status located in Kalimantan Tengah province and is engaged in oil palm plantations and is integrated with its processing units. The company operates with 2,138 workers in plantations and processing units. PT. KKP has been certified by the RSPO since 2017 and this year will undergo the Recertification. The implementation of the RSPO for one cycle has provided continuous improvement in the company's operations which also maintains alignment with environmental preservation, social aspects and sustainability.

PT KKP is not currently undergoing the NPP process.

The RACP process for PT Karunia Kencana Permaisejati has received SATISFACTORY status from RSPO Compensation on November 4, 2020.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001:2015) and Environmental Management System certification body (ISO 14001:2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification Body of Indonesian Sustainable Palm Oil (ISPO), Since March 2014, MUTU has been accredited by ASI (Accreditation Services International) as a RSPO certification body.
