GAR has applied to Mutuagung Lestari and will conduct Re-Certification at PT SMART Padang Halaban POM and its supply based, located at Perkebunan Padang Halaban Village, Aek Kuo Sub District, Labuhan Batu District, Sumatra Utara, Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Padang Halaban POM has successfully been registered in the PalmTrace IT platform with member RSPO\_PO1000001079. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 4 (four) estates on **27 June to 01 July 2022**.
