Nutreco has identified palm oil as agricultural ingredients with a high sustainability risk and where external verification of the requirements in our agricultural supplement is mandatory or preferred.

Palm oil purchased by Nutreco must meet the requirements of the certification scheme of Roundtable for Sustainable Palm Oil according to one of their supply chain options (all options are viable):

- Book and Claim (green palm certificates will need to be purchased for the equivalent amount of palm oil bought)

- Mass balance (an amount of RSPO certified palm oil has been mixed with an amount of non-certified palm oil)

- Segregated (RSPO certified palm oil)

In the case of palm kernel oil, palm kernel meal or palm kernel expeller there is not a mandatory requirement that the product must be approved according to the certification scheme of Roundtable for Sustainable Palm Oil.
