Dear Stakeholders,

Public Notification on upcoming RSPO Certification Assessment of PT Dharma Satya Nusantara Palm Oil Mill 3 and its Supply Base, PT Dharma Intisawit Nugraha and PT Dewata Sawit Nusantara, in Muara Wahau, East Kalimantan Province, Indonesia.

PT Dharma Satya Nusantara has applied to PT TUV Rheinland Indonesia for assessment of one of their holdings against the Roundtable on Sustainable Palm Oil Principles and Criteria – Indonesian National Interpretation (INA-NI). The assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

PT Dharma Satya Nusantara owns and operates 3 mills for processing the crop from all estates under Dharma Satya Nusantara Group located in Muara Wahau, East Kalimantan Province. PT Dharma Intisawit Nugraha is one of the estates under Dharma Satya Nusantara Group which supplies to PT Dharma Satya Nusantara Palm Oil Mill 3 with the total area is 9,797 Ha, total planted area 8,749 Ha, and total production of 212,312 tonnes. PT Dewata Sawit Nusantara is another estate under Dharma Satya Nusantara Group which supplies to PT Dharma Satya Nusantara Palm Oil Mill 3 with the total area is 13,629.9 Ha, total planted area 8,359 Ha and total production for mill is 58,681 tonnes. PT Dharma Satya Nusantara is a member of RSPO and has been actively involved in the each Roundtable international conference. PT Dharma Satya Nusantara Palm Oil Mill 3 is implementing a program to achieve RSPO Certified Sustainable Palm Oil for all its production since December of year 2012

Scope of assessment:

The RSPO certification assessment will cover PT Dharma Satya Nusantara Palm Oil Mill 3 and its supply based PT Dharma Intisawit Nugraha and PT Dewata Sawit Nusantara will be schedule to commence from 25 until 31 August 2013. The assessment shall be carried out for 1 (one) Palm Oil Mill and 3 (three estates) Oil Palm Plantations of PT Dharma Intisawit Nugraha and 4 (four estates) Oil Palm Plantations of PT Dharma Intisawit Nugraha and 4 (four estates) Oil Palm Oil mill and plantations to be assessed are as follows:
