Invitation to comment on RSPO Certification Assessment of Minamas Plantation – SIME DARBY GROUP, Indonesia (PT Teguh Sempurna)

Dear Stakeholders,

Sime Darby Plantation Operation in Indonesia collectively called Plantation Upstream Indonesia. PT Minamas Gemilang and PT Anugerah Sumber Makmur managed the operation in Indonesia known as Minamas Plantation.

MINAMAS Plantation has applied to PT. Mutuagung Lestari for assessment of PT Teguh Sempurna, located in Kalimantan, Indonesia, against the requirement of The National Interpretation of Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO INA-NIWG, May 2008), Republic of Indonesia.

MINAMAS owned and operated 23 palm oil mills and 68 estates throughout Indonesia. The organization is a pioneering member of RSPO and has been taking an active role in the RSPO certification processes. MINAMAS Plantation is implementing programme to achieve RSPO Certified Sustainable Palm Oil for all of its production by 31 December 2011.

Mutuagung Lestari has planned to conduct the proposed certification assessment of PT Teguh Sempurna which minimum 30 days prior assessment. (Scheduled on September 20th, 2010 – September 25th, 2010).
