<u>Public Notification on Upcoming RSPO Re-certification Assessment of PT Perkebunan Nusantara</u> III, Sei Mangke Palm Oil Mill, Simalungun District, North Sumatera, Indonesia.

PT Perkebunan Nusantara III, Sei Mangke Palm Oil Mill (POM) has applied to PT TUV Rheinland Indonesia for re-assessment of one of their holdings against the Roundtable of Sustainable Palm Oil Principles and Criteria – Indonesian National Interpretation (INA-NI). The re-assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

PT Perkebunan Nusantara III is a member of the RSPO and has been actively involved in every international conference held by the RSPO. PT Perkebunan Nusantara III has been getting a RSPO Certificate since October 2010 (RSPO certificate number: 824 502 14008).

Scope of assessment:

The RSPO re-certification assessment of PT Perkebunan Nusantara III, Sei Mangke POM is scheduled to commence from **06 to 11 April 2015**. The assessment shall be carried out for one palm oil mill and 5 (five) palm oil plantations in Simalungun District and Serdang Bedagai District, North Sumatera region.
