<u>Public Notification on Upcoming RSPO Re-certification Assessment of Sampoerna Agro</u> <u>Certification Unit – PT Aek Tarum, South Sumatera, Indonesia.</u>

Sampoerna Agro, PT Aek Tarum, Ogan Komering Ilir (OKI) District, South Sumatera Province has applied to PT TUV Rheinland Indonesia for re-assessment of one of their holdings against the Roundtable on Sustainable Palm Oil Principles and Criteria, Generic Standard year 2013, and Supply Chain Standard year 2014. The re-assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

Sampoerna Agro is a member of the RSPO (membership number : 1-0031-07-000-00 since January 10, 2007) and is committed to full compliance with the Roundtable on Sustainable Palm Oil Principles and Criteria (RSPO P&C). PT Aek Tarum has been getting a RSPO Certificate since Jun 9th, 2011 (RSPO certificate number : TNI-RSPO-009.2010 by TUV Nord).

Scope of assessment:

The RSPO re-certification assessment of Sampoerna Agro, PT Aek Tarum is scheduled to commence from **April 18-22**, **2016**. The assessment shall be carried out for 1 (one) palm oil mill and 2 (two) palm oil plantations and 3 (three) smallholders in OKI District, South Sumatera Province. The details of the management units to be assessed are as follows:
