Public Notification on Upcoming RSPO Re-certification Assessment of Wilmar International Limited, PT Tania Selatan, South Sumatera, Indonesia.

Wilmar International Limited, PT Selatan, Ogan Komering Ilir (OKI) District, South Sumatera Province has applied to PT TUV Rheinland Indonesia for re-assessment of one of their holdings against the Roundtable on Sustainable Palm Oil Principles and Criteria, Generic Standard year 2013, and Supply Chain Standard year 2014. The re-assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

Wilmar International Limited is a member of the RSPO (membership number : 2-0017-05-000-00 since August 15, 2005) and has been actively involved in every international conference held by the RSPO. PT Tania Selatan has been getting a RSPO Certificate since May 2011 (RSPO certificate number : 824 502 14006).

Scope of assessment:

The RSPO re-certification assessment of Wilmar International Limited, PT Tania Selatan is scheduled to commence from **March 14 to 18, 2016**. The assessment shall be carried out for one palm oil mill and 2 (two) palm oil plantations in OKI District, South Sumatera Province. 
