<u>Public Notification: RSPO Initial Certification Audit of Ban Nadoem Oil Palm Collaborative Farming</u> Community Enterprise (RSPO Membership: RSPO 1-0365-22-000-00)

Dear Stakeholders.

This is to inform that Ban Nadoem Oil Palm Collaborative Farming Community Enterprise with RSPO membership number (1-0365-22-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Initial Certification (Eligibility and MSA). Audit located at Community Hall, Village No 3, Tharuea Sub-District, Ban Nadoem District, Suratthani Province. The audit will be conducted from 12-14 December 2023 against the requirements of RSPO Independent Smallholder Standard For the Production of Sustainable Palm Oil, endorsed by the RSPO Board of Governors and adopted at the 16th Annual General Assembly by RSPO Members on 6 November, 2019. The supply chain model is Identity Preserved.

Organization background: Organization Ban Nadoem Oil Palm Collaborative Farming Community Enterprise located in Community Hall, Village No 3, Tharuea Sub-District, Ban Nadoem District, Suratthani Province, Thailand. The organization was legally established on 09 April 2021. Organization consists of 31 smallholder members managing 37 land parcels with total 65.12 Ha oil palm plantation. The smallholder member of Ban Nadoem Oil Palm Collaborative Farming Community Enterprise received training, guidance and accompanied by GIZ Thailand and RSPO Thailand Coordinator. The smallholder members committed to support sustainable oil palm.


