# Public Notification: RSPO Initial Certification Audit of Tha Mapla Oil Palm Grower Community Enterprise (RSPO Membership: 1-0369-22-000-00)

Dear Stakeholders.

This is to inform that Tha Mapla Oil Palm Grower Community Enterprise with RSPO membership number (1-0369-22-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Initial Certification (Eligibility and MSA). Audit located at No. 48, Moo 3, Tha Mapla Sub-district, Langsuan District, Chumphon Province, 86110 Thailand. The audit will be conducted from 18-20 December 2023 against the requirements of RSPO Independent Smallholder Standard For the Production of Sustainable Palm Oil, endorsed by the RSPO Board of Governors and adopted at the 16th Annual General Assembly by RSPO Members on 6 November, 2019. The supply chain model is Identity Preserved.

The smallholder members committed to support sustainable oil palm.


