Dear Stakeholders.

This is to inform that PT. Mirza Pratama Putra – Sumber Cahaya POM, subsidiary of PT. Sawit Sumbermas Sarana, with RSPO membership number (1-0111-07-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Initial Certification Audit located in Kalimantan Tengah Province. The audit will be conducted from 17-19 April 2023 against the requirements of RSPO P&C 2018 – Indonesian National Interpretation 2020. The supply chain model is Mass Balance.


