<u>Public Notification: RSPO Initial Certification Audit of Belian POM, PT. Paramitra Internusa Pratama, part of Golden Agri Resources, Ltd (RSPO Membership: 1-0096-11-000-00)</u>

Dear Stakeholders.

This is to inform that PT. Paramitra Internusa Pratama – Belian POM, subsidiary of Golden Agri Resources, Ltd., with RSPO membership number (1-0096-11-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Initial Certification Audit located in Kalimantan Barat Province. The audit will be conducted from 7-9 December 2022 against the requirements of RSPO Independent Smallholder Standard – Indonesian National Interpretation endorsed on 14 February 2022. The supply chain model is Mass Balance.

Organization background: GAR is the world second largest palm oil plantation with a total planted area of 433,200 hectares as of 30 June 2010, in Indonesia. It has integrated operations focused on the production of palm-based edible oil and fat products. Founded in 1996, GAR is listed on the Singapore Exchange since 1999 with a market capitalisation of US\$4.59 billion as on 30 June 2010. GAR has several subsidiaries, including PT SMART Tbk (SMART) which is listed on the Indonesia Stock Exchange in 1992. GAR is focused on sustainable palm oil production. Primarily, cultivating and harvesting of oil palm trees; processing of fresh fruit bunch into crude palm oil (CPO) and palm kernel; and refining CPO into value-added products such as cooking oil, margarine and shortening. Through its subsidiaries, GAR operates palm oil processing mills, refineries and kernel crushing plants. PT. Paramitra Internusa Pratama – Belian POM located in Kapuas Hulu Regency, Kalimantan Barat Province, Indonesia consist of 2 company-owned oil palm plantations and 1 mill.


