This is to inform that Koperasi Serba Usaha Suka Makmur (1-0428-23-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Recertification (Eligibility, MSA, MSB) Audit located in Sumatera Utara Province. The audit will be conducted from 31 January – 3 February 2024 against the requirements RSPO Independent Smallholder Standard 2019 – Indonesia National Interpretation, February 2022. 
