<u>Public Notification on upcoming RSPO Certification Initial Assessment of KUD Permai Jaya and its independent outgrowers, in Kencana Sari Village, Kikim Timur Sub-District, Lahat District, South Sumatera Province, Indonesia.</u>


KUD Permai Jaya has applied to PT TUV Rheinland Indonesia for assessment of one of their holdings against the Roundtable on Sustainable Palm Oil (RSPO) for Group Certification of FFB Production, RSPO Accreditation and Certification Requirements for Group Certification of FFB Production. The assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

KUD Permai Jaya is an organization of independent outgrowers, held in South Sumatera Province, and registered in deed of notary public named KUD Permai Jaya No. 00226/BHPAD/KWK.6/V/1996 dated 13th of May 1996. This organization held to create the welfare for its outgrowers and to promote sustainable palm oil in South Sumatera Province. KUD Permai Jaya has more than 124 independent outgrowers in 678.66 ha plantation area. KUD Permai Jaya has also registered as RSPO member on 10th of March 2017 with Member ID Number 1-0235-17-000-00.

Scope of assessment:

The RSPO certification assessment of KUD Permai Jaya in Lahat is scheduled to commence from 6th to 10th of November 2017. The assessment shall be carried out for KUD Permai Jaya and palm oil plantation of its independent outgrowers. The details of the organization to be assessed are as follows:
