<u>Public Notification on Upcoming RSPO Recertification Assessment of PT REA Kaltim Plantations, Perdana POM, Kembang Janggut Sub-District, Kutai Kartanegara District, East Kalimantan, Indonesia.</u>

PT REA Kaltim Plantations, Perdana POM has applied to PT TUV Rheinland Indonesia for Recertification Assessment against the RSPO P&C and Supply Chain. Recertification Assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the Indonesia National Interpretation of the RSPO Principles and Criteria for Sustainable Palm Oil Production 2018.

PT REA Kaltim Plantations, Perdana POM is a member of the RSPO (RSPO Membership Number: 1-0045-07-000-00 & Palmtrace Member ID No. : RSPO_PO1000000143) and has been actively involved in every international conference held by the RSPO.

Scope of assessment:

The RSPO Recertification assessment of PT REA Kaltim Plantations, Perdana POM is scheduled to commence from **April 5th – 9th 2021.** The assessment shall be carried out for 1 palm oil mill, and 2 palm oil plantations in Kutai Kartanegara District, Eats Kalimantan Province.
