Public Notification on Upcoming RSPO Re-Certification Assessment of PT. Bumi Sawit Kencana, Sebabi Village, Telawang Sub-District, Kotawaringin Timur District, Kalimantan Tengah Province, Indonesia.

PT. Bumi Sawit Kencana has applied to PT TUV Rheinland Indonesia for re-certification Assessment against the Roundtable of Sustainable Palm Oil (RSPO) Principles and Criteria, Indonesia National Interpretation standard year 2016 and the Roundtable of Sustainable Palm Oil (RSPO) Supply Chain Certification System standard year 2014 Rev. June 2017. The re-certification assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

PT. Bumi Sawit Kencana is subsidiary of Wilmar International Limited, a member of the RSPO (RSPO Membership Number: 2-0017-05-000-00) and has been actively involved in every international conference held by the RSPO.

Scope of assessment:

The RSPO Re-Certification assessment of PT. Bumi Sawit Kencana is scheduled to commence from **23rd to 27th July 2018**. The Re-Certification assessment shall be carried out for one palm oil mill and two palm oil plantations in Sebabi Village, Telawang Sub-District, Kotawaringin Timur District, Kalimantan Tengah region.
