Public Notification on upcoming RSPO Certification Initial Assessment of UD Lestari and its independent outgrowers, in Simpang Kebun Kopi 1 Village, Sei Cuka Sub-District, Batu Bara District, North Sumatera Province, Indonesia.

UD Lestari has applied to PT TUV Rheinland Indonesia for assessment of one of their holdings against the Roundtable Sustainability Palm Oil Group Certification of FFB Production (March, 2016). The assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

UD Lestari is an organization of independent outgrowers, held in North Sumatera Province, and registered in deed of notary public named UD Lestari No. 17 dated 28th October 2013. This organization held to create the welfare for its outgrowers and to promote sustainable palm oil in North Sumatera Province. UD Lestari has more than 63 independent outgrowers in 207.21 ha plantation area. UD Lestari has also registered as RSPO member on 23 November 2016 with Member ID Number 1-0220-16-000-00.

Scope of assessment:

The RSPO certification assessment of UD Lestari in Batu Bara is scheduled to commence from **March 6th** to **March 9th, 2017**. The assessment shall be carried out for UD Lestari and palm oil plantation of its independent outgrowers. The details of the organization to be assessed are as follows:
