#### Notification on RSPO Initial Assessment (Stage-2) of CRS.3 POM – PT Citra Riau Sarana (WILMAR International Ltd)

Dear Stakeholders,

PT Mutuagung Lestari will conduct Assessment at PT Citra Riau Sarana – CRS.3 Palm Oil Mill and its supply base, located in Giri Sako Village, Logas Tanah Darat Sub-district, Kuansing District, Riau Province, Indonesia against the requirement of the RSPO Standard i.e. National Interpretation of Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO INA – NIWG, May 2008) Republic of Indonesia and Supply Chain Requirment for CPO Mill.

WILMAR Int. operates 36 palm oil mills and 46 estates. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes. WILMAR Int is implementing program to achieve RSPO Sustainable Palm Oil requirement for all of its production. Currently there are 10 (ten) under WILMAR International Ltd. have certified.
