Invitation to comment on RSPO Initial Assessment of FELDA Global Ventures Plantations (Malaysia) Sdn Bhd — Besout Palm Oil Mill and supply base, Sungkai, Perak, Malaysia

FELDA Global Ventures Holdings Berhad (FGV) (RSPO Membership No: 1-0225-16-000-00) has appointed BSI to conduct RSPO Initial Assessment of its Besout Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 2 Oil Palm Plantations which are managed by FELDA Global Ventures Plantations (Malaysia) Sdn Bhd (FGVPM). The certification unit is located at Sungkai, Perak, Malaysia

BSI plans to conduct initial assessment of Besout Palm Oil Mill from 6th until 8th February 2018. The assessment will be conducted based on the Malaysian National Interpretation of RSPO P&C for Sustainable Palm Oil Production: MYNI 2014 and RSPO Supply Chain Certification Standard – CPO Mills (Revised 14 June 2017).
