Invitation to comment on RSPO Initial Assessment of FELDA Global Ventures Plantations (Malaysia) Sdn Bhd — Bukit Sagu Palm Oil Mill and supply base, Kuantan, Pahang, Malaysia

FELDA Global Ventures Holdings Berhad (FGV) (RSPO Membership No: 1-0225-16-000-00) has appointed BSI to conduct RSPO Initial Assessment of its Bukit Sagu Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 4 Oil Palm Plantations which are managed by FELDA Global Ventures Plantations (Malaysia) Sdn Bhd (FGVPM). The certification unit is located at Kuantan, Pahang, Malaysia

BSI plans to conduct initial assessment of Bukit Sagu Palm Oil Mill from 5th until 7th September 2017. The assessment will be conducted based on the Malaysian National Interpretation of RSPO P&C for Sustainable Palm Oil Production: MYNI 2014 and RSPO Supply Chain Certification Standard – CPO Mills: 21 November 2014. The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by RSPO P&C.
