Invitation to comment on RSPO Initial Assessment of Takon Palm Oil Mill and Plantations

Carotino/ JC Chang Group (RSPO Membership No: 2-0029-06-000-00) has appointed BSI to conduct RSPO Initial Assessment of its Takon Palm Oil Mill and Plantations. The assessment will be conducted The assessment will be conducted at 1 Palm Oil Mill and 4 Oil Palm Plantations which is managed by Carotino/ JC Chang Group. The certification unit is located at Lahad Datu, Sabah.

BSI plans to conduct Roundtable Sustainable Palm Oil (RSPO) Certification initial assessment of the Takon Palm Oil Mill and Plantations from 28^{th} October -1^{st} November 2019 and 2^{nd} November 2019 for Supply Chain Certification Standard. The assessment will be conducted based on the Malaysian National Interpretation of RSPO P&C for Sustainable Palm Oil Production: MYNI 2014 and RSPO Supply Chain Certification Standard – CPO Mills: June 2017.
