## Invitation to comment on RSPO Re-Certification Assessment of Sime Darby Plantation Sdn Bhd, Tanah Merah Palm Oil Mill – Port Dickson, Negeri Sembilan, Malaysia.

Sime Darby Plantation Sdn Bhd (RSPO Membership No: 1-0008-04-000-00) has appointed BSI to conduct RSPO Recertification assessment of its Tanah Merah Palm Oil Mill and supply base. The assessment will be conducted in 1 Palm Oil Mill and 2 Oil Palm Plantations which are managed by the company. The company is located at Tanah Merah Estate, Jalan Lukut-Sepang, 71009 Port Dickson, Negeri Sembilan, Malaysia.

BSI plans to conduct re-certification assessment of Tanah Merah Palm Oil Mill on 24th to 27th February 2015. The assessment will be conducted based on the RSPO P& C 2013, Malaysia National Interpretation: MY- NIWG: (MYNI 2010), RSPO Supply Chain Certification Standard Module D – CPO Mills: Identity Preserved 21 November 2014. The assessment will also start to evaluate the company's implementation on new RSPO Principles and Criteria for the Production of Sustainable Palm Oil: 2013. The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by RSPO P&C.
