Invitation to comment on RSPO Recertification Assessment of Sime Darby Plantation Sdn Bhd, Elphil Palm Oil Mill and supply base, Sungai Siput, Perak, Malaysia.

Sime Darby Plantation Sdn Bhd (RSPO Membership No: 1-0008-04-000-00) has appointed BSI to conduct RSPO Re-certification assessment of its Elphil Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 3 Oil Palm Plantations which are managed by the company. The certification unit is located at Sungai Siput, Perak, Malaysia.

BSI plans to conduct re-certification assessment of Elphil Palm Oil Mill from 22nd to 25th March 2016. The assessment will be conducted based on the Malaysian National Interpretation of RSPO P&C for Sustainable Palm Oil Production: MYNI 2014 and RSPO Supply Chain Certification Standard – CPO Mills: 21 November 2014.
