Invitation to comment on RSPO Recertification Assessment of Sime Darby Plantation Berhad – Sandakan Bay Palm Oil Mill, Sandakan, Sabah, Malaysia

Sime Darby Plantation Berhad (RSPO Membership No: 1-0008-04-000-00) has appointed BSI to conduct RSPO Recertification Assessment of its Sandakan Bay Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 5 Oil Palm Plantations which are managed by Sime Darby Plantation Berhad. The certification unit is located at Sandakan, Sabah, Malaysia

BSI plans to conduct recertification assessment of Sandakan Bay Palm Oil Mill from 25-27 June 2018.
