Sime Darby Plantation Berhad (RSPO Membership number: 1-0008-04-000-00) has applied to PT SGS Indonesia to conduct RSPO P&C Recertification Assessment for one of their management Unit Sukamandang Mill, PT Kridatama Lancar and Its Supply Bases (RSPO Palm Trace number: RSPO\_PO1000000322).

The Recertification Assessment scope is **Sukamandang Mill PT Kridatama Lancar**, 4 (four) own Estate, as supply base located at Seruyan Tengah Sub District, Seruyan District, Kalimantan Tengah, Indonesia against the requirement of RSPO P&C National Interpretations for Indonesia (INANI April 2020), in conjunction with RSPO Certification System 2020 (November 2020).

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on 22 – 27 March 2022.
