The Recertification Assessment scope is **Alur Dumai Mill PT LTS**, 1 (one) own Estate as supply base located at Village of Sri Kayangan, Sub-district of Tanjung Medan, District of Rokan Hilir, Province of Riau, Indonesia, against the requirement of RSPO P&C National Interpretations for Indonesia (INANI April 2020), in conjunction with RSPO Certification System 2020 (November 2020).
