



#### Figure 2. Location Permit Area Map of PT. Gunajaya Ketapang Sentosa







Figure 4. HCV Area Map of PT. Gunajaya Ketapang Sentosa






Figure 5. Land Cover Map of PT. Gunajaya Ketapang Sentosa




Figure 6. Soil Map of PT. Gunajaya Ketapang Sentosa

#### SUMMARY FROM SEI ASSESSMENTS:

A Participative PT Gunajaya Ketapang Sentosa Social Environmental Impact Assessment (SEIA) has been conducted separately. The Social Impact Assessment (SIA) conducted by RSPO approved HCV assessors Dr.Ir.H.Nyoto Santoso, MS as Team Leader on 2-15 April 2011 and the Environmental Impact Assessment (AMDAL) conducted by government accredited assessors.

The SEIA field work which included in-depth interviews, as well as Focus Groups Discussions (FGD) and direct observations. Main issue studied in the assessment is company profile and general condition of the plantation area covering Air Quality Decrease and Noise Quality Increase, River Water Quality Decrease, Soil Erosion, Land Fire Potency, Flora and Fauna Biodiversity, Job Opportunities, Community Income Generate, Community Health and Workers facilities. In general, the management strategy of social aspect should be aimed at 4 (four) main issues, namely: Settling tenure issues, Settling Plasma development issues, CSR programs and communications with stakeholder's issues

The assessment is also conducted to identify the demand of transparency aspect (principal 1) and legal compliance as well as applicable law (principal 2) stated in P&C RSPO Indonesia, community perception upon plantation, as well as the existence of conservation area based on HCV toolkit Indonesia.

The SEIA covered a review of documentary sources are collected through Focus Group Discussion (FGD), indepth interview, government policy, and village profile data; besides, the assessment also covered field observation and public consultation meetings for the villages within the project area and for affected landowners of surrounding communities. Summaries and findings of the interviews and public consultation meetings are included in the EIA report.

The field observation conducted on 12, 13, 16-18 April 2011. The assessment activities contained through preparation, field survey, public consultation, peer review and final reporting.

The assessment included satellite imaginary analysis, collecting secondary data, extensive field surveys (mapping and landscaping, fauna aspect assessment, flora aspect assessment, Social culture economic aspects assessment) and public consultations with the communities living in the project area for example on Ketapang District, Kendawangan Sub-district, Seriam village. The HCV assessment report included recommendations for the management and improvement of the HCV found within the project area.

The HCV identified in the PT.Gunajaya Ketapang Sentosa operational area clearly mapped. Based on identification and analysis of HCV presence there are found HCV1.1, HCV1.2, HCV1.3, HCV4.1, and HCV6 with total area coverage of 19.56 ha (0.194% from the total concession area of 10,068.56 Ha). No area supporting HCV 2, HCV 3 and HCV5 are identified. Location Plan and the area to be open was not in the area of primary forest. This area is also on the Land Alocated for Other Purposes (APL/Areal Penggunaan Lain).

#### 2. Interview with local community on PT Gunajaya Ketapang Sentosa project area

The results of interviews with local people (Seriam Villagers) known that the process of socialization and land acquisition for the PT Gunajaya Ketapang Sentosa project area conducted with free prior and inform consent. The communities accept the Oil Palm Plantation development plan.

## SUMMARY OF PLANs:

The management plan of PT Gunajaya Ketapang Sentosa has incorporated the findings from EIA (AMDAL), Social Impact Assessment (SIA) and HCV assessment for implementing the operational plans. Recommendations and also conclusion as result of EIA and HCV has integrated in the management plan and consistent with RSPO P&C for New Plantings.

# **VERIFICATION STATEMENT:**

Land development of PT Gunajaya Ketapang Sentosa has been carried out since 2007 prior to HCV Assessment; the company has made voluntary disclosure of liability in July 2014 on areas cleared without prior HCV Assessment; and the company is in the process of, and taking the necessary steps as required in accordance to the RSPO remediation and compensation procedure.

PT Gunajaya Ketapang Sentosa opted for a document and field verification to conduct the New Planting Procedure. Mutuagung Lestari auditors have conducted desk study and discussions with sustainability officers during the desk verification. Two Mutuagung Lestari auditors were conducted the verification on 15 to 16 March 2014 to review and verify the relevant document, interview with local villagers, field observation of HCV area and also interview with the management representatives.

The EIA (AMDAL) conducted by the government approved consultants as well as the HCV and SIA assessments conducted by RSPO accredited and approved assessors. PT Gunajaya Ketapang Sentosa has adhered to RSPO New Planting Procedure and documented the assessments and plans are comprehensive and professionally carried out according to RSPO requirements and comply with the applicable RSPO Principles, Criteria and indicators for new plantings.
