The audit will be conducted from 20-25 June and 28 June 2022 against the requirements of RSPO Principles & Criteria 2018

## Company background

United Palm Oil Industry Public Company Limited or UPOIC has been a pioneer in the palm oil industry in Thailand since the company's first field crops were planted in 1978. Currently, Lam Soon (Thailand) Public Company Limited has been acquired. Company shares in the shareholding proportion of 69.9 percent. United Palm Oil Industry Public Company Limited operates the oil palm plantation business in Thailand. It has its own crude palm oil mill and palm kernel oil mill. Its main products are crude palm oil and crude palm kernel oil. UPOIC is the main supplier of crude palm oil to the Company.

UPOIC is certified to standards such as ISO9001, OHSAS, GMP, HACCP, and TIS18001; Therefore, the relevant management documentation system is in place and well implemented. Most of the employees who work in mills and industrial estates have been working with the company for more than a decade. However, several training programs are organized every year to improve employee knowledge and motivation. A computerized system, or SAP, is a useful tool for tracking and isolating records of certified FFBs supplied from their own land and unqualified FFBs supplied by smallholders. in mass balance control, Easier-to-use tools in excel have been created to take advantage of their computerized alignment. As all the land has been developed for over three decades, it is part of the community with the local people. Most of the employees come from communities around the industrial estate and mills.

The production volume of United Palm Oil Industry Public Company Limited is 75 cubic meters/hour. for the extraction plant in Krabi which is the center of palm cultivation in the southern region of Thailand Approximately 40% of fresh bunches are obtained from the plantations of palm bunches. And about 60% is bought from small farmers.
