

Notification of RSPO Re-Certification 1 Assessment of NACIONAL AGRO INDUSTRIAL S.A, GUATEMALA RSPO Membership: 2-0987-19-000-00

To Whom It May Concern:

NACIONAL AGRO INDUSTRIAL S.A of Guatemala has commissioned SCS Global Services to conduct an RSPO Re-Certification 1 Assessment of its palm oil mill and supply basin located near Finca Primavera I, Aldea Las Camelias, KM 367, Sayaxché, Petén, 17010, Guatemala. The assessment will be conducted of 1 Palm Oil Mill and 1 Oil Palm Plantations.

SCS Global Services plans to conduct the Re-Certification 1 assessment of the NACIONAL AGRO INDUSTRIAL S.A mill from 15/01/2024 – 19/01/2024. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&Cs for the **Guatemala 2021**).
