Notification of RSPO Re-Certification Assessment of Poliamba Ltd PAPUA NEW GUINEA RSPO Membership: 1-0008-04-000-00

To Whom It May Concern:

New Britain Palm Oil Limited (NBPOL)- Poliamba Ltd.a subsidiary of Sime Darby Plantation Bhd in Papua New Guinea has commissioned SCS Global Services to conduct an RSPO Re-Certification Assessment of its palm oil mill and supply base located near Kavieng District, New Ireland Province, Papua New Guinea. The assessment will be conducted on 1 Palm Oil Mill and 5 Oil Palm Plantations (Nucleus) and 3 Scheme Smallholder.

SCS Global Services plan to conduct the Re-Certification assessment of **New Britain Palm Oil Limited (NBPOL)- Poliamba Ltd.** mill from 7th **to 11th February 2022**. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&Cs for **PNG and Solomon Island/2019**).

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
