

## Notification of RSPO Initial Assessment of Palmeros del Aguan S.A (PALMASA), Honduras RSPO Membership: 2-0355-12-000-00

To Whom It May Concern:

Palmeros del Aguan S.A (PALMASA) of Honduras has commissioned SCS Global Services to conduct an RSPO Initial Assessment of its palm oil mill and supply base located near Carretera N-39. Km185, Tepic. Bonito Oriental, Colón, Honduras. The assessment will be conducted of 1 Palm Oil Mill and 27 Outgrowers.

SCS Global Services plans to conduct the Initial assessment of the Palmeros del Aguan S.A (PALMASA) mill from **1 - 5 August, 2022.** The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018 including Supply Chain requirement for mills), using as reference the National Interpretation of the P&Cs for the **Honduras, June 2021**).

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
