Public Notification: RSPO Initial Certification Audit of Brabanta Palm Oil Mill, Socfin SA (RSPO Membership: 1-0269-19-000-00)

Dear Stakeholders,

This is to inform that Brabanta Palm Oil Mill under the Parent company Socfin SA with RSPO membership number (1-0269-19-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Initial Certification Audit located at Ilebo territory, Kasai province, Democratic Republic of Congo. The audit will be conducted from 30/08 to 02/09/2021 against the requirements of RSPO Principles & Criteria 2018.

RSPO PO ID number of the Brabanta Palm Oil Mill is: RSPO_PO1000011313

The Socfin Group specializes in the development and management of oil palm plantations and rubber tree plantations. To date, the Socfin Group is present in 8 Central African countries and 2 countries in Southeast Asia, managing a total of 15 agro-industrial projects. The Socfin Group's strength is based on its expertise and the integrated nature of its activities, but also on its knowledge of the sector and its adaptability to current social issues.

The "Brabanta" plantation was created at the beginning of the 20th century by the "Plantations et Huileries of the Belgian Congo - HCB", on an original concession of 23,000 ha.

HCB was founded by "Lever Brothers", which later became the Unilever group. The first opening works of the plantation began in 1916, and the first blocks were planted in 1923.

The first planting period was between 1923 and 1941, during which 5,242 hectares of oil palm trees were planted. An additional 777 ha of Tenera oil palm trees were planted during the second period, from 1956 to 1960. The company was nationalized in 1975 and reintegrated into the Unilever group in 1978, it was then called "HUILMA" for "Huilerie de Mapangu" within PLZ "Plantations Lever Zaire". The Unilever group sold its plantations in South Congo, including Huilma, in the 1980s in a process of gradual disengagement from the country.

From 1968, the 1,341-ha of oil palms in Sanga Sanga, Kadima and Kanangai were exploited in the form of scheme smallholding by independent service providers supervised by the company. This situation still existed when the Socfin group acquired Huilma in 2007. The Huilma company was then renamed Brabanta.

The 3 estates were replanted between 2009 and 2014 with 1,341 ha of new generation palm trees. In 2014, the company finalized the construction of an 18 MT/hr palm oil mill.
