<u>Public Notification: RSPO Recertification Audit of Bunga Tanjung POM, PT. Agro Muko, SIPEF Group (RSPO Membership: 1-0021-05-000-00)</u>

Dear Stakeholders,

This is to inform that PT. Agro Muko – Bunga Tanjung POM under the Parent company SIPEF Group with RSPO membership number 1-0021-05-000-00 had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Recertification Audit located at Bengkulu Province. The audit will be conducted from 23 - 30 October 2021 against the requirements of Indonesia National Interpretation 2020 of the RSPO P&C 2018

RSPO PO ID number of the PT. Agro Muko – Bunga Tanjung POM is: RSPO PO1000001279.

SIPEF is a Belgian private agro-industrial Group registered under Belgian Law. Its shares are quoted on the Stock Exchange of Brussels (Euronext). The Company was incorporated in 1919 with the principal aims of promoting and managing plantation companies which would operate in both tropical and sub-tropical areas. In the past two decades, SIPEF has concentrated its activities on the production of palm oil (in Indonesia and Papua New Guinea), rubber and tea (in Indonesia), and bananas (in Côte d'Ivoire). The Group sells its own products throughout the world. PT. Agro Muko – Bunga Tanjung POM located in Mukomuko Regency, Bengkulu Province, Indonesia with certification unit consist of 1 (one) palm oil mill, 4 (four) oil palm estates and 4 (four) cooperatives as scheme smallholder under company management.
