This is to inform that PT. Indotruba Tengah – Sekunyir POM under the Parent company Sime Darby Plantation Berhad with RSPO membership number 1-0008-04-000-00 had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Recertification Audit located at Kalimantan Tengah Province. The audit will be conducted from 11-16 April 2022 against the requirements of Indonesia National Interpretation 2020 of the RSPO P&C 2018
