**Société Africaine Forestière et Agricole du Cameroun (Safacam)** of Cameroon a has commissioned SCS Global Services to conduct an RSPO Certification Assessment of its palm oil mill and supply base located in Littoral Region, Department of the Sanaga Maritime, Dizangué District, near the city of Edéa, CAMEROUN. The assessment will be conducted of 1 Palm Oil Mill, and 1 Oil Palm Plantation.
