Notification of RSPO Certification Assessment of Agroservicios El Triunfo S.A. RSPO Membership Number: 1-0296-20-000-00

To Whom It May Concern:

Agroservicios El Triunfo S.A. a has commissioned SCS Global Services to conduct an RSPO Initial Certification Assessment of its palm oil mill and supply base located near Kilómetro 221 entrada carretera Nuevo Chuatuj; Caserío Villa Flores, Coatepeque, Guatemala. The assessment will be conducted of 1 Palm Oil Mill and 1 Estate.

SCS Global Services plans to conduct the Certification assessment of **Agroservicios El Triunfo S.A.** from **23 to 27 of August 2021.** The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018), with updated Supply Chain requirements for Mills.
